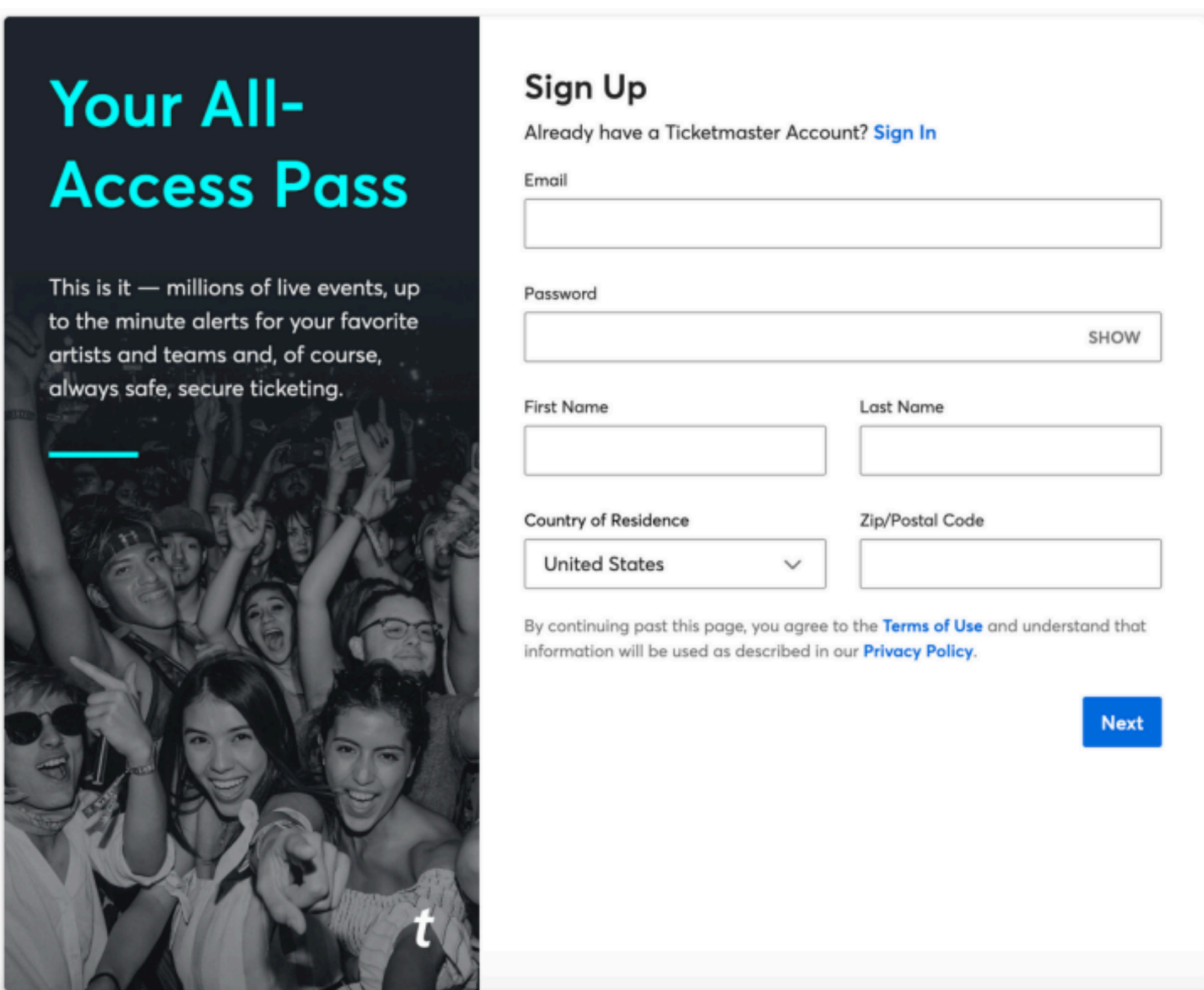
3. Sports Where I Am confirmation

You will receive an email from Sports Where I Am, confirming your seat location, information about accessing your tickets and expected delivery timeframes. For Ticketmaster, this can be up to 72 hours before the event.



4. Ticketmaster Ticket Acceptance Email

When your tickets are ready, Ticketmaster will send you an email asking you to accept your tickets. You can do this by clicking the Accept Tickets link in the email.



5 (a). Log in to Ticketmaster

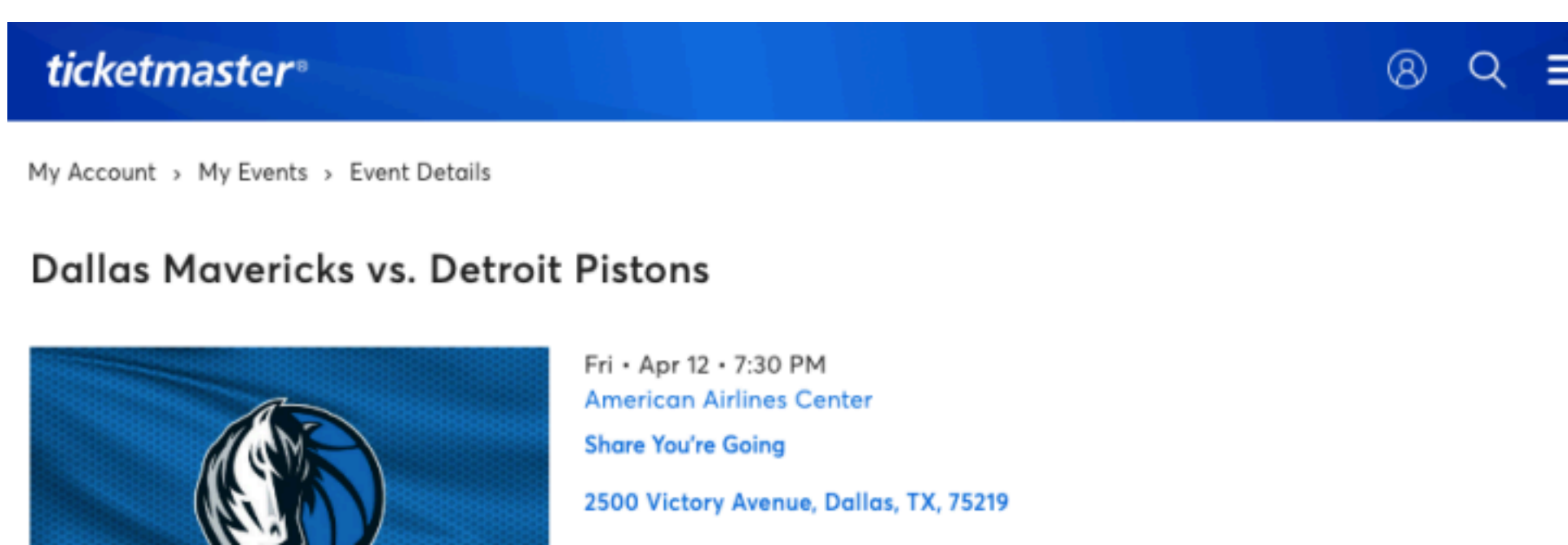
If you have an existing Ticketmaster account, sign in using your credentials at the log in screen.

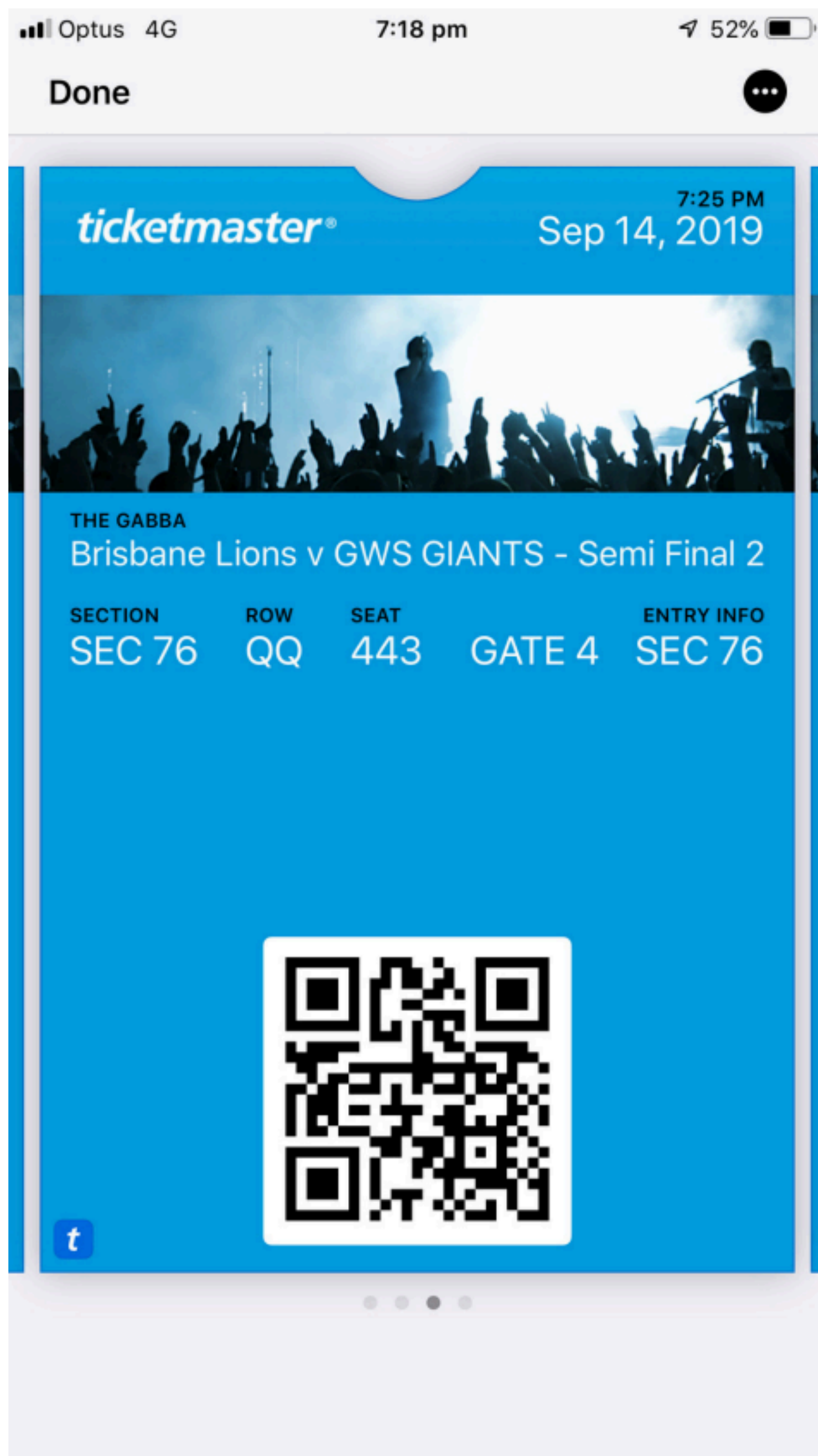
5 (b). Sign up for Ticketmaster

If you don't have an existing Ticketmaster account, you will need to quickly sign up for one by completing the fields on the sign up screen. You will receive another email to confirm your new account and then you're ready to go.

6. Access Tickets

Now that you've accepted your tickets, in the "My Events"





menu of your Ticketmaster account (visible in the app and on your mobile browser), you will be able to see and access your ticketing for entry into the event.

7. Present Ticket at Venue

Now that you are able to access your mobile ticket, load this up via your Ticketmaster account in either the Ticketmaster App or your mobile browser while at the venue for scanning and access into the event. You can also add this to your Google or Apple Wallet for easy access at the time of entry.

All venues that use mobile ticketing have Free WiFi available at the gates, so you will be able to access your ticketing at any time while at the venue.
